






Reduce the mortality rate for infants aged under 1 years old from 3\2






Reduce the mortality rate of children under 5 years old from  $3\2$ 






#### Reduce the maternal mortality rate from 4\3

More than 2,500 jobs were created, reducing staff turn








Integrated Health information system operating on-line based on DHIS2 program was created






Initiated the use of telemedicine in the diagnosis and treatment of patients


Needy mechanism of social services through "Single Window" was initiated

#### **Education Sector Achievements**

#### Strengthening and development of education sector

- ✓ Provision and approval of 5 regulations and 7 state programs on different sectorial levels development;
- ✓ increase of 300 000 seats;
- ✓ full implementation of the computerization program;
- ✓ complete collection of statistics;
- ✓ adoption of the "Concept of National Inclusive Education";
- 5% increase in the enrollment of children in proschool education compared to the 2007
- ✓ 1071 units of children development centers;




#### **Education Sector Achievements**

#### Strengthening and development of education sector

- ✓ introduction of per-capita financing;
- ✓ 400 000 students in the primary grades were provided with a hot meal;
- ✓ centralized exams through the National Testing Center under the President of the Republic of Tajikistan;
- implementation of the multistage and credit system of education

# Achievements in Labour, Migration and Population Employment Sector Increaseing:



### Challenges in health and population's social protection sector

- ✓ Purposeful funding of sectorial national programs;
- ✓ strengthening the material-technical base of the health facilities for comprehensive access to health services and ensure the quality of medicines;
- ✓ activities in improving maternal and child nutrition, nutrition movement of global expansion,
- ✓ strengthen the medium term expenditure planning Program;

### Challenges in health and population's social protection sector

- ✓ improvement and expansion of the government guarantee program in other cities and regions of the country;
- ✓ gradual introduction of the collection accumulation of funds and new funding mechanism at the regional and hospital levels;
- ✓ finding a sources for the establishment of mechanisms on introduction of compulsory medical insurance;
- improvement of activities to cope with the HIV TB and vaccine preventable diseases;

### Challenges in health and population's social protection sector

- ✓ finding funds for introduction of new efficient vaccines and drugs;
- ✓ widening the mechanism of social assistance;
- ✓ establishment of information database on social protection sector;
- ✓ Development of a Strategy for further development of social protection.



#### Challenges in Education sector

- ✓ The indicator of children's coverage in preschool education in the country does not correspond to the modern requirements;
- ✓ There is no necessary infrastructure in educational institutions for the full implementation of the National Concept on Inclusive Education;
- ✓ Preparation for transition to a twelve year education system and revisiting the curriculum and education plans, application of competency-based standards and improvement of in-service training of sectorial employees requires more resources;



#### Challenges in Education sector

✓ Implementation of School Feeding Programme in all general education institutions and sustaining this system requires time and additional resources;

✓ Vocational education should be constantly developed along with the internal and external labour market needs.



### Challenges in Labour, Migration and Population's Employment Sector

- ✓ Lack of a formal evaluation system on effectiveness of state government employment proprietary on level of unemployment;
- ✓ conducting research on jobs and labor force surveys;
- ✓ establishment of a network on integrated computerized information-analytical state employment agencies;
- conducting research to identify the demand for areas and sector specialists.



### Challenges in social insurance and pension sector

- ✓ Timely appointment of pensions and social benefits and provision of funding;
- ✓ continue to reform pension support system and starting January 1, 2017 fully implementation of the pension insurance system in the country;
- ✓ development and improvement of sector legal system;
- ✓ sustainable development of the financial system in terms of pension insurance, depending the size of pensions and social benefits to the contributions paid by citizens;



### Challenges in social insurance and pension sector

- ✓ continue transition to a system of pension payments through bank cards in other cities and regions;
- ✓ to take account of the insured persons in the state social insurance system;
- ✓ formation of a reliable database on salaries and other benefits of insured persons for the provision of pensions and social benefits;
- ✓ solutions to social insurance coverage for migrant workers individuals who work in other countries;



### Challenges in social insurance and pension sector

- ✓ Extensive use of modern information technology in the process of SSI payment of pensions and social benefits;
- ✓ Investment banks with the aim of maintaining inflation of free accumulation of public pension funds.
- ✓ Within the financial capability of the budget of social insurance and pensions, gradually increase the amount of citizen's pension.
