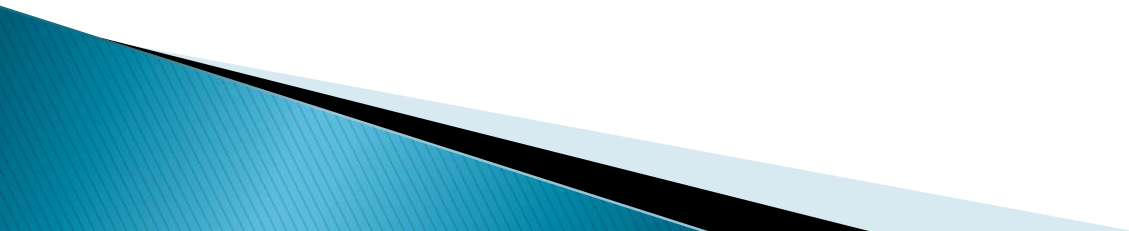

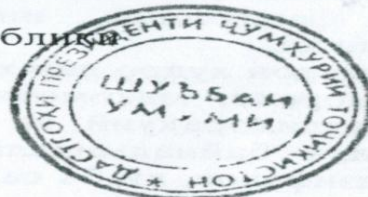


1. Образовать Национальную платформу Республики Таджикистан по снижению риска стихийных бедствий.

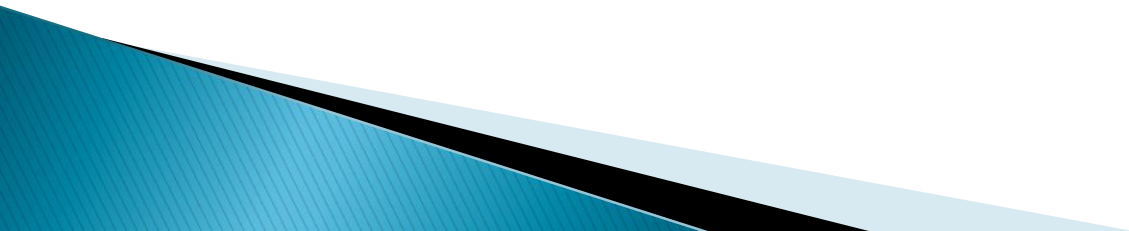

- ▶ Formed under the State committee of the Republic of Tajikistan for Emergency situations and is –
 - ▶ consulting and advisory body, operating through the existing mechanism for coordination among organizations and agencies of the Republic of Tajikistan on disaster risk reduction and strategic leadership to create a global platform for disaster risk reduction.

The national platform carries out its mandate in cooperation with public authorities, ministries and departments, local executive authorities of the government, NGOs, private sector and civil society in the framework of the tasks within the competence of the National Platform



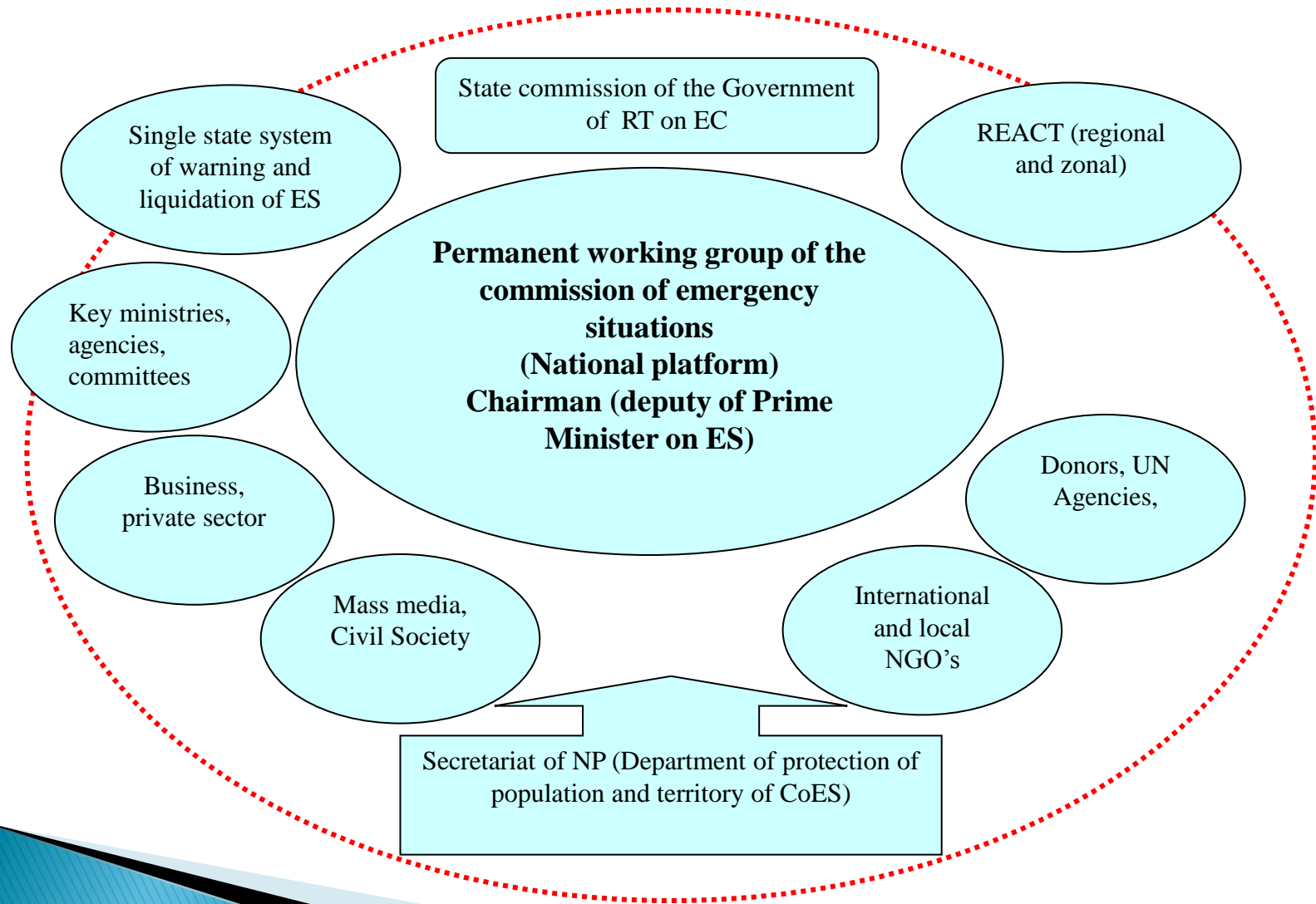



Organisational structure of NP on DRR in Tajikistan.




National Platform of Tajikistan has been developed with the aim of:

- Formation and coordination of activities in the area of DRR and man made disasters and also loss of human lives and economical losses;
 - Conducting consultations on inclusion of DRR regulations into strategies, plans and development programs.
- 

The main tasks of NP of Tajikistan:

- Development of proposals and recommendations on the formation and conduct of the coordination of disaster risk reduction and man-made disasters, as well as human and socio-economic losses;
- Coordination, analyses and consultation on priority direction on disaster risk reduction which require joint agreed action on national level;
- Provision of progress in achievements of goals of DRR, conducting monitoring in the area of DRR
- Ensuring participation of various sectors of society in discussing actions in the area of DRR
- Coordination of establishment and functionality of thematic working groups, considering knowledge, experience and opinion of all interested parties in the area of DRR;
- Provision of monitoring of implementation of programs and projects, recommendations and other documents and decisions by organizations in the area of DRR;
- Cooperation and collaboration with regional, international, donors and specialized organizations in the area of DRR.
- Organization of learning of use of international experience during the process of liquidation of disasters and coordination of cooperation of ministries and departments of the republic in the area of DRR in the frame of obligation of the RT as the result of agreements and contracts;
- Development and coordination of programs and common methodology for assessing the risk of natural disasters in this area;
- Use and implementation of international experience in program development and evaluation of the impact of the risk of natural disasters on the environment
- The use and implementation of international experience in program development and evaluation of the impact of the risk of natural disasters on the environment;
- Promotion of disaster risk reduction at different levels.

The system of functioning of NP of Tajikistan:

- ▶ Meetings are called whenever necessary, but at least once per quarter. All decisions of the NP should be included in a protocol;
 - ▶ Organizational and technical support should be provided by CoES under the Government of RT;
 - ▶ Secretariat – Department of protection of population and territory of CoES and GO under the government of RT.
